Grampian Gallop Tour 20 July 2025

SUPPLEMENTARY REGULATIONS

The Grampian Gallop on Sunday 20 July continues the new CCHMSC format of affordable classic and sporting car motorsport to encourage those wishing to try a motor sport event, perhaps for the first time. The event will start and finish at the Festival Theatre Pitlochry. The tour will cover some 170 miles over interesting roads across the highlands of Scotland with Scotlish high tea at the finish and presentations. The event is open to all members of CCHMSC and members of the Saltire Rally Club.

1. Announcement:

The Grampian Gallop will be held on Sunday 20 July 2025 and is organised by the CCHMSC Ltd. The event will start and finish at the Festival Theatre Pitlochry, Port-Na-Craig Rd, Port na Craig, Pitlochry PH16 5DR. The Start and finish location will be issued with the final instructions.

2. Jurisdiction:

The event will be held under the general rules of the Motorsport UK as a Touring Assembly and these Supplementary Regulations and any written instructions that the organising club may issue for the event. Motorsport UK Certificate of Exemption 201681 has been issued.

3. Eligibility:

The event is open to all members of the Caledonian Classic and Historic Motor Sport Club, and members of the Saltire Rally Club, plus any other MSUK registered club. Membership of CCHMSC may be added to the entry form if required (£5 per person)

4. Vehicles:

The event is open to the following:

- a) Cars manufactured before 1980.
- b) Sporting and saloon cars of any age.
- d) Other cars permitted at the discretion of the organisers.

Cars constructed before 1980 will be given preference for entry.

5. Entry List:

The entry list opens on publication of these regulations and entry form.

The entry list closes on Monday 14 July 2025.

Refunds for withdrawn entries will be at the discretion of the organisers.

6. Scrutineering

Pre event document inspection and signing on will take place from 9.00am at the start location. The first car will depart at 10.00am and you will be given your start time in the final instructions.

Entrants will be required to sign a declaration to say that they have the following

- A valid MOT certificate. (if applicable)
- A valid Road Fund Licence

 A minimum of Third Party Insurance for all persons who will drive the participating vehicles must be applicable for the duration of the event.
Cars must comply with the Motorsport UK regulations for the event.

7. Route, Navigation and Driving Behaviour:

The route will be on public A and B class and unclassified roads all on sealed surfaces. The route instructions will be supplied along with the final instructions, before signing on, prior to the start. Entrants should bring a road atlas of Scotland to transfer the route instructions on to create a marked up map.

8. Participants must at all times comply with the requirements of the Road Traffic Acts and drive in a responsible and considerate manner. Please remember other road users, cyclists, walkers and livestock. NOTE 20mph speed limits through villages. Quiet roads are designated walking and cycling routes and have a 40 mph speed limit.

10. Entries:

The entry fee is £50. This includes a rally plate, route instructions and meal for two at the finish. Breakfast will be available at the start if required, at entrants own cost. All entries must be made on the entry form and accompanied by the appropriate fee. Entries will be accepted in order of receipt. Maximum number of entries is 50, with a minimum of 20.

12. Awards:

A finishers award will be presented to all entrants completing the route and reaching the finish venue.

13. Insurance:

Participants are responsible for ensuring that all drivers of vehicles entered in the event are fully covered by insurance during the event as required by the Road Traffic Acts and will be required to sign a declaration to that effect at the start. All crew members will also be required to sign a declaration at the start on the signing on sheet indemnifying the organisers and Motorsport UK from liability.

14. Data Protection Act:

Prospective entrants and competitors are advised that information supplied on the entry form will be held on a computer and used for the administration of the event.
