SUPPLEMENTARY REGULATIONS

The Tour of the Wall will start at Dobbie's Garden Centre, Edinburgh. The route will include some new and little known roads in the Scottish Borders and North of England covering approximately 210 miles of interesting and scenic roads and an opportunity to visit some of the historic Roman remains on Hadrian's Wall. There will be a good mix of fast and twisting roads. There will also be a suggested lunch stop opportunity on route. Tea and coffee will be available to purchase at the start and a buffet tea will be provided at the finish venue.

1. Announcement:

The Tour of the Wall will be held on Sunday 25th March 2018 and is organised by the CCHMSC Ltd. The event will start Dobbie's Garden Centre, Melville Nursery, Lasswade, Midlothian, Edinburgh EH18 1AZ and finish near Blyth Bridge for presentation of awards and buffet tea. The Start and finish locations will be issued with the final instructions.

2. Jurisdiction:

The event will be held under the general rules of the MSA as a Touring Assembly and these Supplementary Regulations and any written instructions that the organising club may issue for the event. An MSA Touring Assembly Permit has been applied for.

3. Eligibility:

The event is open to all members and non-members of the Caledonian Classic and Historic Motor Sport Club Ltd.

4. Vehicles:

The event is open to the following:

- Cars manufactured before 1980.
- Sporting cars of any age.
- Other cars permitted at the discretion of the organisers.

Cars constructed before 1980 will be given preference for entry.

5. Entry List:

The entry list opens on publication of these regulations and entry form. The entry list closes on Monday 19th March 2018. Refunds for withdrawn entries will be at the discretion of the organisers.

6. Documentation:

Pre event document inspection and signing on will take place from 8.30am at the start venue. The event will start at 9.30am and you will be given your start time in the final instructions.

7. Scrutineering

Entrants will be required to sign a declaration to say that they have the following

- A valid MOT certificate (where applicable).
- Valid Road Tax
- A minimum of Third Party Insurance for all persons who will drive the participating vehicles must be applicable for the duration of the event.

Cars must comply with the MSA regulations for the event.

8. Route, Navigation and Driving Behaviour

The route will be on public A and B class and unclassified roads and will all be on sealed surfaces. The route will be supplied after inspection of documentation and signing on, prior to the start. It will take the form of a Tulip Roadbook.

Participants must at all times comply with the requirements of the Road Traffic Acts and drive in a responsible and considerate manner. Please remember other road users, cyclists, walkers and livestock.

9 Entries

The entry fee is £35 including 2018/19 Club Membership to 31 March 2019. Existing CCHMSC members £30. This includes a Tulip Roadbook, rally plate, and meal at the finish for two. All entries must be made on the entry form and accompanied by the appropriate fee. Maximum number of entries is 50. Entries will be accepted in order of receipt. No email entries will be accepted. All entries must be on the official entry form, with the appropriate fee enclosed
